

of taxes in areas with a high concentration of low-income housing, such as Ellenville and Kingston, while residents of towns like Rochester would take a big hit. "People just can't afford it," said Chipman.

Bernardo kicked off her campaign with a lunch at the Accord Fire House, where she made available petitions for all three of the parties (Republican, Independence, and Conservative) which have endorsed her. She spoke to a full house as she touted her legislative accomplishments, such as raising awareness of the leaking New York City aqueduct in Napanoch. She also touched upon a budget controversy, in which \$2.1 million of unanticipated Federal money was received after the budget was agreed upon; Bernardo voted with a minority of legislators to return the money to taxpayers.

The county chairs of all three parties endorsing Bernardo were present to show their support at her event. Perhaps most notable is Independence chair Len Bernardo, whose

ELECTION LAW

§ 17-122. Misconduct in relation to petitions

Any person who:

1. Pays, lends, contributes or promises to pay, lend or contribute any money or **other valuable consideration** to or for any voter, or to or for any other person, to induce such voter to sign a petition for the designation of a candidate for party nomination or for election to a party position to be voted for at a primary election, or to induce such voter to sign a petition for opportunity to ballot at a primary election or to induce such voter to sign an independent nominating petition for public office...
...is guilty of a misdemeanor.

She was born in Kingston to the late Marion S. and Alice L. Palen Jones. Her husband, John Santosky died on Sept. 26, 1990. She is survived by six sons, Richard of South Carolina, Ronald of Accord, John Jr. of South Carolina, Spencer of Accord, Larry of Wawarsing and Joseph Santosky of Poughkeepsie; five daughters, Virginia Canton of Kingston, Shirley Kneet of Kingston, Deborah Santosky of Coxsackie, Dorothy Jolley of Kerhonkson, and Yolanda Cianci of Ellenville; two brothers, Richard and Roger Jones of Kingston; 35 grandchildren and many great grandchildren. Jacobsen could not have possibly witnessed a deceased person signing a petition, the material false statement shall subject her to the same penalties as she had been duly sworn. This is District Attorney's territory.

In light of the fact that databases show only one Lisa K. Fraser in New York State, the following news item published in *Daily Freeman* is relevant to this objection as it shows yet another Post Office address used by Lisa K. Fraser, the witness of Sheets # 16 and #17:

The following items are based on information provided by officials in law enforcement and the criminal justice system.

CITY OF KINGSTON

DWI: Lisa K. Fraser, 50, of P.O. Box 3136, Kingston was arrested Wednesday at 11:52 a.m. by Kingston police and charged with two counts of misdemeanor drunken driving.

The Appellate Division of the Supreme Court of the State of New York, Third Department, in the Matter of William F. Sheehan, Appellant, v. George P. Scaringe et al., Constituting The Albany County Board of Elections, et al., Respondents found that...

"...the post-office address requirement is analogous to the requirement of Election Law that a subscribing witness set forth his or her election and assembly district. This requirement is considered not one of form but one of content, for which there should be strict compliance (see, Matter of **Liss v Sadowski**, 59 N.Y.2d 635, 636). Our inquiry, then, is not whether the omission is misleading or likely to cause misidentification or confusion, but rather whether the required information is specified on the petition. In the absence of the required post-office addresses being specified, petitioner's objections in this regard must be upheld.

- 54.** The signer on line 10 (Lucy A. Kump) is not a registered Republican. She is a NOP, making a false statement about being a "duly enrolled voter of the Republican Party and entitled to vote at the next primary election of such party."

Also, line 10 shows the town of Rochester instead of town of Wawarsing.

I hereby petition the Ulster County Board of Elections to void the signature of Lucy A. Kump (line 10).

- 55.** The signer on line 11 (Ralph Veiland) signed Sheet #152 on July 11, 2011. He previously signed candidate Manuela Michalescu's petition Sheet #13, line 1, on June 22, 2011 (Witness: Kandy Santosky).

Also, line 11 shows the hamlet (Kerhonkson) instead of the town (Rochester).

I hereby petition the Ulster County Board of Elections to void the signature of Ralph Veiland (line 11).

- 56.** The signer on line 12 (Imre Beke, Jr.) signed Sheet #152 on July 10, 2011. He previously signed on Sheet #23, line 3, on June 12, 2011 (Witness: Fawn A. Tantillo).

Also, on Sheet #152, line 12, the date is out of order (July 10 after July 11).

I hereby petition the Ulster County Board of Elections to void the signature of Imre Beke, Jr. (line 12).

- 57.** The signer on line 13 (Imre Beke, Sr.) is also the witness for this petition sheet. One cannot witness his own signature.

Also, Imre Beke, Sr. previously signed on Sheet #22, line 17, on June 17, 2011 (Witness: Terry L. Bernardo).

I hereby petition the Ulster County Board of Elections to void the signature of Imre Beke, Sr. (line 13).

Specific objections to ALL Republican Party Designating Petitions submitted for Ulster County Legislature District 21 candidate Terry L. Bernardo

- 58.** On all Republican Party Designating Petitions submitted for Ulster County Legislature District 21 candidate Terry L. Bernardo, the "Name of Candidate" is given as "Terry L. Bernardo."

All petitions fail to adequately indicate the "Name of Candidate."
In Ulster County Board of Elections' records the name is Terry Lynn Bernardo.

I hereby petition the Ulster County Board of Elections to void all Republican Party Designating Petition sheets submitted for Ulster County Legislature District 21 candidate Terry L. Bernardo and remove the candidate's name from the Republican Party line on the ballots prepared for the Primary Election to be held on September 13, 2011.

In light of the above listed specific objections, some exposing fatal deficiencies in the Republican Party Designating Petitions submitted for Ulster County Legislature District 21 candidate Terry L. Bernardo – and the fact that they are sufficient to disqualify her Petitions as a whole – I hereby petition the Ulster County Board of Elections to disqualify said Petitions and remove the candidate's name from the Republican Party line on the ballots prepared for the Primary Election to be held on September 13, 2011.

I do hereby state that I am a duly enrolled Republican voter in the Ulster County Legislative District 21, and entitled to vote at the next Primary Election to be held on September 13, 2011.
