Resume of Toby Stover:

I moved to the community of Rochester in November, 1980 after living in Poughquag, NY for 2 1/2 years. At the time my son was one and 1/2 years old. We moved here to a 57 acre old farm at 81 Clove Valley Road, High Falls. Since then we have created a thriving organic permaculture vegetable farm here.

For most of the years raising our two children, I was working as a piano player in "Fennig's All Star String Band". I joined this band in 1973 and still play with them after 40 years. We have 5 CD's to our credit. We play for monthly community dances in Albany.

The Vanaver Caravan is a traditional music and dance company out of Rosendale and New Paltz. We are very involved in educating children in our local community. We have been working in the Rondout School District, as well as many other school districts in Ulster and Dutchess Counties. We work with the Social Studies programs to introduce children to cultures of the world through dance and music.

When my children were in high school, I went back to school & became certified in "Burnham Systems Facial Rejuvenation". I started a practice in Rosendale.
